They are the part of criminal investigations. ### Legal nurse consultants (LNC)

LNC is a registered nurse (RN) who offers medical advice regarding legal matters. LNCs review and evaluate legal data. Legal nurse consultants advise on legal matters using their expertise in healthcare also advice on medical facts and evidence for ongoing cases to their clients.

## Forensic psychiatric nurses

A registered nurse (RN) specialized in psychiatric nursing are known as a forensic mental health nurse, or forensic psychiatric nurse (FPN). In order to comprehend the mental health of both criminals and victims of crime, forensic mental health nurses apply their nursing education, which integrates elements of medicine and law. They assist individuals who have suffered physical or emotional trauma.

### **Correctional nurse consultants**

Quality health care services are offered by correctional nursing specialists to people under court custody, including those in jail, juvenile detention centres, and other facilities. Their duties include caring of ill, conducting regular physical examinations, and giving medication.

#### Forensic Nurse Death Investigators (FNDI)

Forensic nurse death investigator, are registered nurse and require at least two years of experience, ideally in an emergency room or critical care setting. They can collaborate with police to identify the precise cause of death and to estimate the time of death. They are typically called to the scene of the crime to investigate the body, obtain samples of blood and tissue, arrange for the body to be brought to the mortuary for an autopsy, and gather evidence that will aid in the investigation of the crime. Forensic nurses can be crucial in the field of death investigation, both at the site of the crime and during post-mortem examination. They could assist with receiving deceased bodies, police paperwork, record-keeping, handling legal requirements, documenting the body's condition, etc. in the mortuary.

# Sexual assault nurse examiner (SANE)

The number of sexual assault cases is rising, and the victims of these horrible acts endure great physical and mental suffering. The victims of sexual assault are easily bonded to by a female forensic nurse. Sexual assault survivors receive immediate medical attention as well as emotional assistance from sexual assault nurse examiners. They record the assault report, conduct the required medical examinations to gather vital evidence, and they might even provide expert witness testimony in court. Additionally, it is their duty to make recommendations for the victim's on-going care. Sexual assault nurse examiner is qualified to perform sexual assault assessments and victim management at the same time. They also offer services to individual clients, victims and family counselling and expert witness in court.

### Forensic nurse educators

Forensic nurse educators also impart knowledge regarding forensic nursing, certification programs and continuing education in forensic nursing. In addition to sexual assault examination techniques, they can instruct students on domestic violence, elder abuse, child abuse, and collecting, preserving, and documenting evidence. They can address a broad range of subjects pertaining to particular forensic nursing roles, such as forensic nurse examiners, forensic psychiatric nurses, and nurse death investigators.

## Nurses' role as a forensic nurse [15, 16]

- Nurses are able to record wounds, gather biological specimens, and save garments that may contain signs of assault.
- 8. Evidence related to poisoning cases—such as vomits, stomach aspirate, urine samples, soiled cloth, etc. qualified forensic nurses can assist with the collection, preservation, and maintenance of the samples'.
- 9. Forensic nurse specialist offers specialized care to victims of intentional or unintentional trauma.
- The nurse conducts physical examinations and takes medical histories, takes medical forensic photos, identifies and gathers evidence, and records the victims' conditions.
- 11. The forensic nurse can act as a nurse educator to the victim's family.
- 12. Nurse record proper documentation for the patient's legal protection.
- Providing physical and psychological care to victims of violent crimes.
- 14. Forensic nurses can gather evidence from both victims and suspects.
- 15. Forensic nurse can play important role in the mortuary by helping to receive deceased bodies, keeping MLC patient records, and handling legal documentation.
